Visa & Passport Information

Destination - New Zealand (NZ)

Passport

Passport required.

Document Validity:

Passports issued to nationals of Netherlands must be valid for at least 1 month beyond the period of intended stay.

Admission and Transit Restrictions:

Holders of passports issued by Netherlands traveling under the New Zealand visa-waiver must hold return/onward tickets.

· Exempt are holders of authorization issued by New Zealand's immigration authorities waiving the return ticket requirement.

Minors:

Minors entering New Zealand may be included in the passport of the parent, who is travelling with them.

WARNING! In accordance with European Union (EU) Legislation, all minors who are nationals of Netherlands will be expected to hold their own passport or National ID Card (where applicable) when departing from Bulgaria, Croatia, Cyprus, Romania or a Schengen Member State.

Visa

Visa required.

Visa Exemptions:

A max. stay of 3 months:

- for nationals of Netherlands:
 - o Passenger must have a return/onward ticket

Additional Information:

Visitors are required to hold proof of sufficient funds to cover their stay. The amount of funds needed is NZD 1,000.- per person per month of stay or NZD 400.- if accommodation has been prepaid. Evidence of funds may be in the form of cash, traveller's cheques, bank drafts, letters of credit or the following credit cards: Diners Club, American Express, Bankcard, Mastercard and Visa. If Visa label contains "Funds Waived", evidence of sufficient funds is not required.

Visitors are required to hold documents for their next destination.

All passengers (except residents of Tokelau) must obtain a permit to enter Tokelau from the Tokelau Apia Liason Office in Apia, at least 2 weeks prior to travel. Tel: +685 20822. Fax: +685 21761. Tokelau can only be reached by boat from Samoa. A permit from the Samoan Immigration Authorities is required to leave and re-enter Samoa.

Transit - Australia (AU)

Visa

Visa required.

TWOV (Transit Without Visa):

The following restrictions are in place depending on transit airport:

- There are no transit facilities available at Gold Coast (OOL).
- Sydney (SYD): Transit without a visa available for eligible passengers only if transiting for max. 8 hours on the same calendar day.
- Transit facilities at Adelaide (ADL) are only available for passengers arriving and departing on the same aircraft, or if advance notice is given by airline.

Additional Information:

Valid visas in full or expired travel documents are accepted provided accompanied by new travel document. Verification by airlines using Australia's Advance Passenger Processing (APP) system will require the details fo the travel document that contains the visa.

Transit - United Arab Emirates (AE)

Minors:

Passport not required for minors registered in their parent/guardian passport, provided it contains photos of the minors and traveling with the passport holder.

Visa

Visa required.

TWOV (Transit Without Visa):

Holders of confirmed onward tickets for a max. transit time of 24 hours.

Visa Issuance

E-visas can be obtained via www.ednrd.ae . These visas are valid for entry at any international airport of the UAE. Airlines can check the validity of an e-visa at the same site by clicking on the "Query DNRD APP" button.

Minors

Separate visa not required for minors registered in their parent/guardian passport, provided their name is endorsed in the visa of the parent/guardian.

Transit - Thailand (TH)

Visa

Visa required.

Visa Exemptions:

A max. stay of 30 days

• for holders of normal, emergency or temporary passports, issued to nationals of Netherlands;

TWOV (Transit Without Visa):

Holders of onward tickets for a max. transit time of 12 hours through Bangkok Suvarnabhumi (BKK).
